- The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The
 relevant books as per the academic level of students shall be made available in the library.
- 7. The School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band connectivity with the feature of 'internet always on' from any service provider to be ensured.

- Every secondary and senior secondary school shall appoint a person on full time basis for performing the duties
- The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws. 36
- The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another 37. Society/Management/Trust through agreement/sale deed. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.

- The school should not start Class IXXXXVXII (as the case may be) without written approval of the Board. The 42. Board shall not be responsible for any consequences in case class IXX/XI/XII are started without obtaining the prior approval of the Board and without following the Affiliation Byelaws.
- It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools, 43.
- In case of established violation of Affiliation Bye laws, directions given in the circulars and any of the above 44. mentioned conditions by the school, the school would be liable for disaffiliation under Chapter V.Rule No. 17 of Affiliation Bye-laws.
